







Commonly Asked Questions Regarding Midleton GAA Park South Development

1. What are we developing & what stage are we at?

Having completed the purchase of the lands (Phase 1), we're now at Phase 2, where we're developing the Entrance, Roadway to Car Park, Car Park, Two full size Juvenile Pitches and a new Sand Based Main Pitch. We broke ground at Park South on 7th May last. A lot of work has been done so far and we're currently working on the two Juvenile Pitches.

2. How will we fund it?

The full cost is €810,000. Own Funds account for €260k, Loans €250k, Grants €100k and Fundraising €200k.

3. When does the Fundraising start?

We've started already and any member of the Fundraising Committee will be glad to help you make your donation right now. You can also make enquiries via our email address midgaadevfund@gmail.com or at treasurer.midleton.cork@gaa.ie.

4. Who are we asking to donate?

All those associated with Midleton and the Club. This includes private individuals, club members present & past, local businesses and industries, and our Midleton diaspora in UK, USA and in other Countries.

5. How much can I give?

While we're looking for donations of up to €1,000 or more, we're happy to accept any level of donation however big or small. For PAYE individuals who donate €250 or above in any Tax Year, Midleton GAA could qualify for extra tax relief that the Club can claim. If you give your permission for this please fill in the "Tax Relief For Donations To An Approved Sports Body" form and either give it to a member of the Fundraising Committee or post it to The Treasurer, Midleton GAA, Clonmult Memorial Park, Midleton, Co. Cork.

6. Business donations

Likewise, we're looking for donations of up to €1,000 or more, but we're happy to accept any level of donation however big or small. Business donations qualify for full corporation tax relief.

7. How are donations acknowledged?

You will get an email acknowledgement from the Club Treasurer. For transparency, the person you are dealing with on the Fundraising Committee, the Club Chairperson and Club Secretary will also be copied on any email to you receipting a donation.

8. Will I be given an update on how Fundraising is progressing?

Yes. Everyone who donates will be included in a group Email. You will be emailed with regular updates on what we have collected and also on the Development. In addition, there will be a fundraising sign at Clonmult Memorial Park which will be updated regularly. This will give an update on the amount raised. 9. How do I donate?

- **c. Standing Order:** If you wish to contribute with a monthly figure. Just fill in and sign the **Standing Order Set Up Form**. If you so wish you can;
 - i) give the signed Standing Order form to a member of the Fundraising Committee, or
 - ii) drop the signed Standing Order form into your own Bank, or
 - iii) post to the Treasurer, Midleton GAA, Clonmult Memorial Park, Midleton, Co. Cork and we will commence the process from there.

Note: If you are a PAYE worker and wish for the Club to also avail of a further Tax Refund, please fill in the "Tax Relief For Donations To An Approved Sports Body" form. This form should only be completed by Donors who pay tax under the PAYE tax system only. You can hand this to a Member of the Fundraising Committee or post to The Treasurer, Midleton GAA, Clonmult Memorial Park, Midleton, Co. Cork.
